#### BLACK FEMALE RENTERS WERE FILED AGAINST FOR EVICTION AT DOUBLE THE RATE OF WHITE RENTERS OR HIGHER IN 17 OF 36 STATES



Data source: The Eviction Lab. Counties without data<sup>2</sup> were excluded from the analysis. States where all counties were excluded or where the sum of all counties' Black populations were less than 1%, are shown in white with a grey border. Five states: Delaware, Georgia, South Carolina, and Vermont filed white tenants for eviction at slightly higher rates than Black women. Ratios were rounded to the nearest tenth.



Most troubling, we found landlords filed for evictions at substantially higher rates in majority Black Community Areas than in other parts of the city. In 2010, 16 of the 19 (84%) Community Areas with filing rates over 50% of the citywide rate of 4.1% were majority Black areas. In 2017, it rose to 23 of 25 (92%) areas when the citywide rate was much lower at 3.1%.

Year	Jurisdiction	Parameters
2017	NYC	200% or below of FPL, some admin proceedings (RTC 2.0: subsidy terminations)
2018	SF	No income limit; admin proceedings
2018	Newark	200% or below of FPL
2019	Cleveland	Families with children at 100% or below of FPL
2019	Philadelphia	200% or below of FPL; admin proceedings and subsidy terminations; appeals; affirmative code violations

## **Eviction RTC pending bills**

Jurisdiction	Parameters
Boulder CO	No income limit; subsidy terminations and admin proceedings
Connecticut	Families making \$50k or less
Los Angeles	Eviction prevention services; ongoing case management; eviction defense for those at 200% or below of FPL. \$12 million allocated so far.
Massachusetts	200% or below of FPL, on public benefits, or unable to pay without losing "necessities of life"
Minnesota	Public housing tenants facing eviction for breach of lease
Santa Monica	Still in development

### **Eviction RTC federal bills**

Member of Congress	Scope
Rep. DeLauro (D-CT)	\$125 million for eviction fund. Priority to jurisdictions with RTC. Also data collection
Rep. Ocasio-Cortez (D-NY)	\$6.5 billion for eviction fund going to states/cities providing RTC

#### **District of Columbia**

#### Tenants w/o counsel:

- 2x likely to be found in breach of lease;
- 3x more likely to be subjected to writ of possession;
- 7x more likely to wind up with consent judgment (less favorable than a settlement agreement)

#### Hennepin County, MN

Pilot found represented tenants:

- Were twice as likely to stay in their homes;
- Received twice as long to move if necessary;
- Were 4x less likely to use homeless shelter.
